**Registration, Participant Agreement, Release and Acknowledgement of Risk**

In consideration of the services by Big Sioux Rifle & Pistol Club, their agents, owners, officers, volunteers, participants, employees, and all other persons, entities, and ranges acting in any capacity on their behalf (hereinafter collectively referred to as "BSRPC"), I hereby agree to release and discharge BSRPC on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that pistol, rifle, and shotgun shooting entail known and unanticipated risks which could result in physical or emotional injury (up to and including death), paralysis, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things; being struck by bullet fragments from impact on backstops, or structure, which my bullets strike. While these are usually low speed fragments, they may cause cuts or welts.

Furthermore, BSRPC volunteers have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless BSRPC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or use of BSRPC equipment or facilities used by BSRPC, including any such Claims which allege negligent acts or omissions of BSRPC.
4. Should BSRPC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume – and bear the cost of – all risks that may be created, directly or indirectly, by any such condition.

**BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS ACTIVITY, I MAY BE FOUND BY A COURT OF LAW TO HAVE WAIVED MY RIGHT TO MAINTAIN A LAWSUIT AGAINST BSRPC ON THE BASIS OF ANY CLAIM FROM WHICH I HAVE RELEASED THEM HEREIN.**
